- 1. Application, payment and liability form must be received by June 24, 2022.**
- 2. All outdoor spaces are 10'x10'. If you need more space you will need to pay for an additional 10'x10' spaces. You must stay within your space at all times.**
- 3. Vendors are allowed to set up that morning, starting at 10-12 AM. You must be set up by 12:00 PM. You will not be able to set after 12 PM.**
- 4. All vendors are required to stay the entire time of the event.**
- 5. The event will take place rain or shine, NO REFUNDS.**
- 6. Duplicate vendors WILL NOT be allowed, (Scentsy, Color Street, Paparazzi etc.)**
- 7. Vendors must supply their own pop-up tents, tables, chairs, etc.**
- 8. Vendors are responsible for their own clean-up and trash disposal. DO NOT LEAVE YOUR TRASH BEHIND.**
- 9. Food Vendors are responsible for obtaining their food permit from Fort Bend County Health Department.**
- 10. Vendors will be prohibited from displaying any products or signage that deemed inappropriate.**
- 11. All Booths must be self-supporting and present a professional appearance.**
