Registration/Check-in: 2:30 p.m. (Needville Youth Fair Barn)

Pet Show starts: 3:00 p.m.

1. Any child living in Fort Bend County up to and including 12 years of age can enter a pet in the PET SHOW.
2. A completed Entry form and Release of Liability Form will be required for each participant.
3. Only one pet can be entered per child.
4. Exhibitor must be accompanied by an adult.
5. Pets must be on a leash or caged. Pets must be owned by the exhibitor or a person in the immediate family.
6. Dogs and Cats: A current rabies vaccination certification for animals 6 months old or older must be available for presentation during registration.
7. Dogs 6 weeks and older must be vaccinated against parvovirus.
8. Owners are responsible for cleaning up after their pet.
9. Awards will be given for each category.
10. Each pet can enter as many categories as they wish.
11. The entry fee for the pet show shall be one or more of the following items to be donated to the
